**PURPOSE OF POSITION:**

To inspect all overhead and underground electric distribution facilities to ensure any sub-standard conditions are identified, reported, and corrected in a timely manner.

***Job Specifications:***

All requirements are subject to possible modification to reasonably accommodate individuals with disabilities. Some requirements may exclude individuals who pose a direct threat or significant risk to the health and safety of themselves or other employees.

1. High School graduate and/or equivalent work experience required
2. Two years work related experience preferred
3. Strong communication skills required deal with the public on a daily basis
4. The ability to work in a team environment
5. Must be a creative thinker with strong problem solving skills
6. Strong organizational skills required
7. Mathematical skills required
8. Regular and punctual attendance is required
9. Driver's license required (CDL Class A is preferred)
10. Experience in the operation and care for an all-terrain vehicle is preferred
11. General computer skills required while prior experience with Microsoft Word and Excel is preferred.
12. Familiarization with working on an IPAD is preferred.

This job description is not intended to be all-inclusive; an employee will also perform other reasonable related job responsibilities as assigned by the immediate supervisor and other management as required. Farmers RECC reserves the right to change job descriptions, job duties, or working schedules based on the needs of the Cooperative.

### ***Working Conditions:***

While performing the duties of this job, the employee is regularly exposed to outside weather conditions, and risk of electrical shock. The employee is occasionally exposed to extreme cold and heat. The noise level in the work environment is usually moderate. Applicant must be able to accomplish work for parameters required as shown on the Farmers Rural Electric physical, environmental, and mental demand form for the System Inspector position. Must be willing and able to work extra hours when necessary and be willing to report to work during non-scheduled hours when needed for emergencies and outages. Some travel outside the service area for training may be required.

### ***Essential Duties/Responsibilities:***

The following are essential responsibilities of this position and do not include marginal functions that are incidental to the performance of the fundamental job duties. The scope and duties of this position may change or be temporarily altered based on the business needs of the Cooperative. The basic requirement of every position is to perform all tasks as assigned by your supervisor. This document does not create an employment contract, implied or otherwise, other than an "at will" employment relationship.

1. Ensure each portion of the system is inspected on a timeline consistent with company policy and Public Service Commission regulations
2. Required to abide by all FRECC policies, procedures, and guidelines.
3. Identify, report, and follow-up on any sub-standard condition/s
4. Communicate with members about sub-standard condition/s for which they are responsible and ensure the condition/s are corrected in a timely manner
5. Assess the condition of poles by sounding and/or boring
6. Document all issues found using "Software" on an IPAD
7. Maintain knowledge of RUS construction specifications for overhead and underground facilities as well as various types of distribution equipment
8. Maintain knowledge of National Electric Safety Code (NESC) requirements for distribution facilities
9. Maintain knowledge of National Electric Code (NEC) requirements for service entrance equipment
10. Maintain knowledge of work order process
11. Occasionally provide assistance to staking technicians
12. Design and stake jobs such as, but not limited to, pole replacements, service replacements, service upgrades, outdoor lights, and new extensions
13. Responsible for use and care of personal protective equipment
14. Required to maintain a valid forklift operator certification
15. Comply with traffic laws, regulations, and safe driving practices while operating any company vehicle.
16. Assist during and after hours in identifying problems associated with service interruptions and outage restorations.
17. Maintain knowledge of system maps
